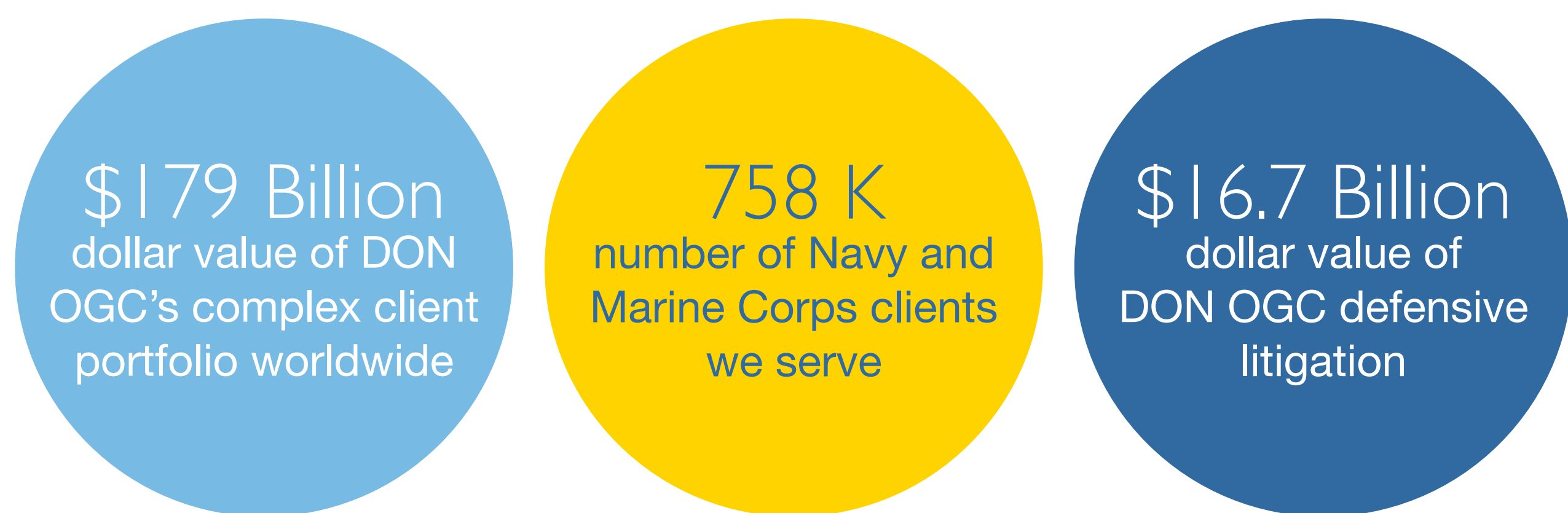

SUPPORTING THE NAVY AND THE MARINE CORPS

- The General Counsel (GC) of the Navy is the Principal Legal Advisor to the Secretary of the Navy. DON OGC attorneys assist the GC in providing legal services to personnel throughout the Navy and Marine Corps.
- We support the Assistant Secretaries for Environment, Installations & Energy; Financial Management & Comptroller; Manpower & Reserve Affairs; and Research, Development & Acquisition.
- Attorneys are also assigned to the Acquisition Integrity Office, Dispute Resolution Office, Naval Litigation Office, Strategic Systems Programs Office, Pacific Fleet, Cyber Command, and Fleet Forces.
- We also serve clients at the Commander Navy Installations Command, the Military Sealift Command, the Naval Air Systems Command, the Naval Facilities Engineering Command, the Naval Sea Systems Command, the Naval Supply Systems Command, the Office of the Commandant of the Marine Corps, the Office of Naval Research, and the Space and Naval Warfare Systems Command.

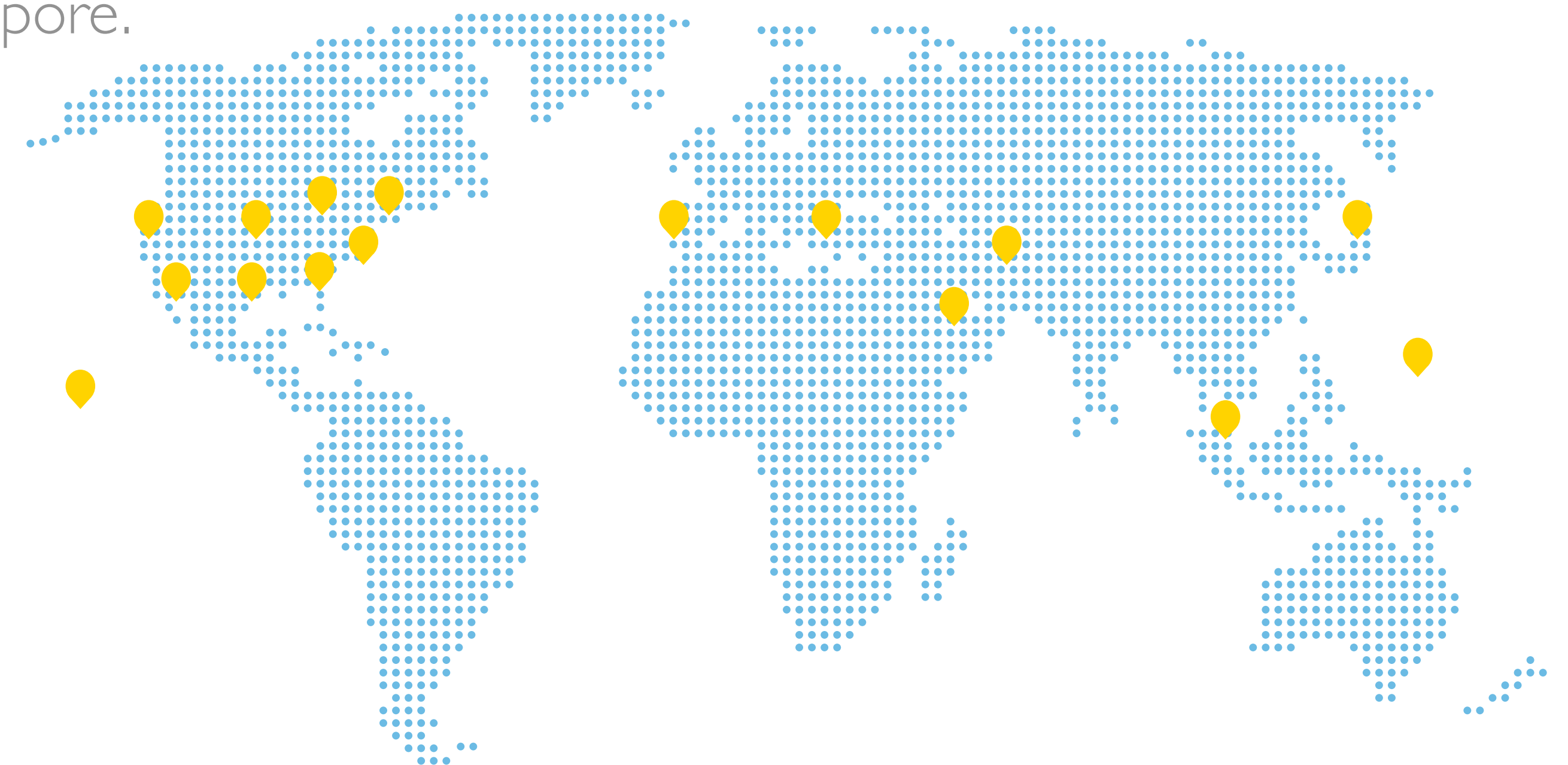


EXAMPLES OF SUCCESSFUL ADVOCACY

- **Supreme Court Litigation.** Supreme Court win in *Winters v. NRDC* protected use of sonar for military training for national security.
- **Cyber Law.** Advised on cyber security readiness for 300 ships and submarines imperative to the warfighter and the fight against terrorism.
- **Combating Fraud.** Curtailed a \$15 million fraud scheme involving optic sights purchased by the Navy.
- **Government Contracts Ship Systems.** Successful defense of a \$1.6 billion contract for a next generation combat radar to improve capabilities of the Navy's fleet.
- **Employment Law.** Defended thousands of compensation, discrimination, employment and labor cases, resulting in significant costs savings to the Government.
- **Government Contracts Aircrafts.** Legal support for F-35 fighter jet program worth over \$300 billion.
- **Real Estate.** Advised on complex lease agreement that enabled temporary relocation of aircraft for critical missions and operations.
- **Support Warfighter.** Legal support for complex \$1.7 billion food services contracts that feeds thousands of Marines nationwide.
- **Intellectual Property.** Patent and trademark licensing brought in over \$5.5 million supporting military families and R&D.

DON OGC attorneys practice in 19 states, plus the District of Columbia and Guam, with over 50% located in the National Capital Area. DON OGC has international offices in Spain, Italy, Djibouti, Bahrain, Japan, and Singapore.

- Over 25% OF DON OGC attorneys practice government contracts law, followed by litigation (13%), and employment/labor law (10%).
