<b>Request Summary:</b>	<p>The following is a work up on the identified Naval Yard Washington DC shooter AARON ALEXIS.</p> <p>On August 29<sup>th</sup> 2011, AARON applied for a TXDL using a discharge from active duty form, a certificate of live birth out of New York City, and a social security card. The DL is current.</p> <p>TWC indicates last employment as 1<sup>st</sup> quarter 2013, possible by temp agency, at Randstand General Partner –US- LLC Et al, 800-738-2430. He shows prior military employment in Texas from quarter 04-2009 to quarter 3-10. He appeared to receive payments from the Liason off/Bureau of Naval Personnel until 06-23-2012.</p> <p>A black 1996 Nissan MGS 4D with TXLP BJH7396 is registered to him. His insurance was current at the time of this check. NVLS was searched for possible hits, there was a sighting of his vehicle on 08-02-2013 at 4:40 am at the resident of 7505 Creekfall Drive, Fort Worth, TX, 76137. A check of the residence does not show a recent application for the residence.
