SECTION IX. NARRATIVE

ON 29MAY09, AT APPROXIMATELY 1355HRS, WHILE PERFORMING ACCESS CONTROL DUTIES AT THE WASHINGTON NAVY YARD, DEFENDANT (b) (6) ENTERED THE ACCESS GATE LOCATED AT THE 600 BLOCK OF "M" ST SE ON FOOT. HE REQUESTED ACCESS TO THE NAVY YARD FOR THE PURPOSE OF CASHING A CHECK AT THE NAVY FEDERAL CREDIT UNION. HE WAS DRESSED IN A BLUE TACTICAL UNIFORM, WEARING A BLUE WINDBREAKER AND DISPLAYING A GOLD-IN-COLOR BADGE HANGING FROM A CHAIN AROUND HIS NECK. UPON CLOSER INSPECTION, THE BADGE READ "SPECIAL POLICE OFFICER". THE REPORTING OFFICER (b) (6) THEN ASKED HIM IF HE WAS ARMED, AND HE RESPONDED "YES". (b) (6) THEN REQUESTED TO SEE HIS PERMIT TO CARRY A CONCEALED WEAPON. THE DEFENDANT PRODUCED ONLY A SPECIAL POLICE IDENTIFICATION CARD, ISSUED BY THE SECURITY OFFICERS MANAGEMENT BRANCH OF WASHINGTON, DC, WHICH STATED THE EMPLOYER'S NAME, (b) (6) (b) (6) ASKED THE DEFENDANT FOR THE LOCATION OF HIS JOB SITE, AND HE REPLIED "RHODE ISLAND AVENUE. I TOOK THE SUBWAY TO COME HERE ON MY LUNCH BREAK". (b) (6) THEN NOTIFIED A SENIOR POLICE OFFICER FOR ASSISTANCE. (b) (6) RESPONDED TO THE SCENE AND PROCEEDED TO CONTACT THE SECURITY OFFICERS MANAGEMENT BRANCH TO INQUIRE AS TO THE LAWFULNESS OF AN SPO CARRYING A CONCEALED FIREARM OFF OF HIS JOB SITE. (b) (6) WAS INFORMED THAT SPOs ARE NOT PERMITTED TO DO SO, AND IT IS UNLAWFUL. DEFENDANT WAS THEN PLACED UNDER ARREST. (b) (6) REQUESTED ASSISTANCE FROM THE UNITED STATES CAPITOL POLICE CRIME SCENE SECTION. (b) (6) RESPONDED AND TOOK POSSESSION OF THE FIREARM AND AMMUNITION FOR EVIDENCE. THE DEFENDANT WAS TRANSPORTED TO USCP HEADQUARTERS (119 "D" ST NE) WHERE HE WAS ADVISED OF HIS RIGHTS AND PROCESSED FOR ATTEMPTED CARRYING OF A PISTOL WITHOUT A LICENSE. DEFENDANT WAS LATER RELEASED ON CITATION AND ISSUED A COURT APPEARANCE DATE.

THE DEFENDANT WAS POSITIVELY IDENTIFIED AS (b) (6) BY HIS (b) (6) DRIVER'S LICENSE,

BEARING A DATE OF BIRTH OF (b) (6)

DURING PRELIMINARY QUESTIONING, THE DEFENDANT STATED THAT HE HAD COME TO THE NAVY YARD SEVERAL TIMES WHILE ARMED, AND THAT HE THOUGHT HE COULD DO IT.

NOTE: DC LAW PROHIBITS SPECIAL POLICE OFFICERS FROM CARRYING FIREARMS OFF OF THEIR JOB SITE LOCATION, AND ALSO FORBIDS THEM FROM DISPLAYING BADGES OR ANY OTHER SYMBOL OF AUTHORITY OUTSIDE OF THEIR JOB SITE.
