

SUBJECT: Class Deviation-- Extension of Biobased Reporting Requirement

Effective immediately, the reporting deadline contained in paragraph (c)(2) of the clause at FAR 52.223-2, Affirmative Procurement of Biobased Products Under Service and Construction Contracts, is extended from October 31, 2012, to December 31, 2012. The United States Department of Agriculture (USDA) has launched a web-based portal to handle reporting required for Fiscal Year 2012. The reporting template and additional information on the reporting process are available at <http://www.biopreferred.gov>. Contractors can submit their reports at the portal.

The Department continues to fully support the policies on the use of biobased products at Federal Acquisition Regulation subpart 23.4 – Use of Recovered Materials and Biobased Products. The extension of the reporting deadline is necessitated by delays in the development and deployment of the web-based portal. The extended deadline will provide contractors the necessary time to report their data to the USDA portal.
