MEMORANDUM FOR THE ACQUISITION COMMUNITY AT LARGE

SUBJ: Recent Suspensions and Debarments

This memorandum provides notice to the Acquisition Community at Large of suspension and debarment actions issued by the Department of the Navy (DON), Acquisition Integrity Office (AIO) since July 31, 2012.

Currently, the Excluded Parties List System (EPLS) is being incorporated into the System for Award Management (SAM). Once the migration of data is complete, SAM will be the sole publication that contains the names of contractors suspended, proposed for debarment, debarred, or declared ineligible for government contracts by any agency of the Federal Government. As a result of EPLS migrating to SAM, there have been technical web performance issues on both the EPLS and SAM websites; as of July 31, 2012, the DON AIO has been unable to create new entries for placing a suspended or debarred company or individual onto the EPLS or SAM websites.

As a temporary measure, to ensure the widest possible distribution providing notice of the DON AIO's most recent administrative actions, below is a list of suspensions and debarments taken by the DON AIO since July 31, 2012. Until the EPLS and SAM websites become operational, the DON AIO will continue to update this list. The DON AIO will provide notice to the Acquisition Community at Large once the EPLS and SAM websites become operational.
