SUBJECT: Department of the Navy Special Interest Items for Review under the Procurement Performance Management Assessment Program

This memorandum establishes a standard list of "Special Interest Items (SIIs)" that are required to be reviewed under the Department of the Navy (DON) Procurement Performance Management Assessment Program (PPMAP). SIIs are acquisition and contracting topics or issues of high visibility within DON. The attached document standardizes the SIIs for review under the DON PPMAP to facilitate continuous improvements in acquisition and procurement policy or processes, as necessary. The attached list is effective January 1, 2014.

Each Head of the Contracting Activity (HCA) shall ensure that personnel responsible for performing procurement management oversight functions address the attached SIIs when performing reviews under PPMAP. HCAs may add other areas of special interest to this list that are unique to the HCA's assigned acquisition mission.

DASN(AP) will review the attached list annually to determine whether specified areas should remain or if other areas should be added, as appropriate.
