
MEMORANDUM FOR DISTRIBUTION

SUBJECT: GAO Report GAO-11-122R, Proper Announcement of Contract Awards

The attached Director of Defense Procurement and Acquisition Policy (DPAP) memorandum (same subject, dated April 2, 2013) is provided for your awareness.

The Report provides that GAO conducted an assessment of all 50 actions submitted to OASD(Public Affairs) on August 6, 2010 against the five criteria required to be included in the announcement. While the overall findings in the Report identified a pattern of issues, the three Navy announcements on that day "generally included the five categories, with only 1 entry missing competition information." While this still indicates slight room for improvement, the DON's concerted efforts to comply are noteworthy. Please continue the vigilance you have demonstrated through your complete submissions. 

SUBJECT: GAO Report, GAO-11-122R, Proper Announcement of Contract Awards

The Government Accountability Office (GAO) issued a report, GAO-11-122R, on November 30, 2010, "DoD Components Are Not Sending Required Information on Contract Awards to the Office of Public Affairs." The GAO analysis revealed that contract award announcements provided to the Office of the Assistant Secretary of Defense for Public Affairs (OASD(PA)) lacked information required by the Defense Federal Acquisition Regulation Supplement (DFARS) Subpart 205.303 and as a result, subsequent contract award announcements were insufficient.

Please ensure that your contracting officers and specialists are appropriately reporting all contractual actions, including modifications that have a face value of more than \$6.5 million in accordance with DFARS 205.303, with all the specific information requirements outlined in that subpart. This reporting does not include unexercised options. This information must be submitted to the OASD(PA) by close of business the day before the date of the proposed contract action award. In addition, all departments and agencies will monitor and verify that all information on contract award announcements, provided to the OASD(PA), are proper and in accordance with DoD regulations.
