RMKS/1. Pending formal amendment to reference (a), this interim change adds
a new article, Article 1168 to reference (a). This interim change is
effective upon the release of this ALNAV.

2. Article 1168 of reference (a) is added to read as follows:

a. 1168. Nonconsensual distribution or broadcasting of an image

(1) The wrongful distribution or broadcasting of an intimate image is
prohibited.

(2) The distribution or broadcasting is wrongful if the person making
the distribution or broadcast does so without legal justification or excuse,
knows or reasonably should know that the depicted person did not consent to
the disclosure, and the intimate image is distributed or broadcast:

(a) With the intent to realize personal gain;

(b) With the intent to humiliate, harm, harass, intimidate,
threaten, or coerce the depicted person; or

(c) With reckless disregard as to whether the depicted person
would be humiliated, harmed, intimidated, threatened, or coerced.

3. Distribution means the act of delivering to the actual or constructive
possession of another, including transmission by electronic means.

4. "Broadcasting" means the act of electronically transmitting a visual
image with the intent that it be viewed by a person or persons.

5. An intimate image is any visual depiction, including by electronic means,
that:

a. Includes another person who is identifiable from the depiction itself
or from information conveyed in connection with the depiction;

b. Depicts that person engaging in sexually explicit conduct or depicts
the private area of that person; and

c. Taken under circumstances in which the person depicted had a reasonable expectation of privacy.

6. "Sexually explicit conduct" is defined in Part IV, paragraph 68b, Manual for Courts-Martial (2016 Edition).

7. "Private area" is defined in Part IV, paragraph 45c, Manual for Courts-Martial (2016 Edition).

8. In lieu of entering this interim change in reference (a), make a bold letter notation after Article 1167 of reference (a), SEE ALNAV 021/17 and file this ALNAV in front of reference (a).

9. This interim change will be incorporated into the next printed revision of reference (a).

RMKS/1. THIS MESSAGE REVISES SPECIFIED ARTICLES OF REFERENCE A. THIS CHANGE
IS
EFFECTIVE IMMEDIATELY.

2. NAVY'S RECENT INVOLVEMENT WITH NATURAL AND MAN-MADE DISASTERS, AS WELL AS
LESSONS LEARNED FROM FORT HOOD SHOOTING INCIDENT, REITERATE THE NEED FOR
CLEAR
COMMAND AUTHORITIES AFLOAT AND ASHORE. IN ACCORDANCE WITH REFERENCE A,
SECTION 0702, COMMANDERS ARE RESPONSIBLE FOR THE SATISFACTORY ACCOMPLISHMENT
OF MISSION AND DUTIES ASSIGNED. AS WITH COMMANDERS OF SHIPS AND AIRCRAFT,
COMMANDERS ASHORE MUST POSSESS AUTHORITIES COMMENSURATE WITH THEIR
RESPONSIBILITIES. REGION AND INSTALLATION COMMANDERS HAVE BROAD
RESPONSIBILITY FOR SERVICE INTERESTS AFFECTING NAVY PROPERTY, PERSONNEL, AND
THEIR FAMILIES. THE BELOW CHANGES CODIFY THESE AUTHORITIES, AS WELL AS ALIGN
COMMAND AUTHORITIES ASHORE WITHIN THE JOINT REGION AND JOINT BASING
CONSTRUCT.

3. ARTICLE 0702 IS AMENDED TO INCLUDE THE FOLLOWING PARAGRAPH AND READS AS
FOLLOWS:

QUOTE

0702. RESPONSIBILITY AND AUTHORITY OF COMMANDERS.

5. NAVY REGION COMMANDERS HAVE THE RESPONSIBILITY TO OVERSEE AND COORDINATE
MATTERS OF WIDE-RANGING SERVICE INTEREST THROUGHOUT THEIR ASSIGNED GEOGRAPHIC
REGION. NAVY REGION COMMANDERS MAY DIRECT THE ACTIONS OF ALL TENANT AND
VISITING COMMANDS, INCLUDING THOSE COMMANDS NOT OTHERWISE ALIGNED TO AN
INSTALLATION, ON MATTERS CONCERNING THE SAFEGUARDING OR PRESERVATION OF NAVY
OWNED OR CONTROLLED PROPERTY AND THE SECURITY, SAFETY AND WELFARE OF ALL
INDIVIDUALS AND FAMILIES ONBOARD NAVY OWNED OR CONTROLLED PROPERTY. THIS
AUTHORITY INCLUDES, BUT IS NOT LIMITED TO, ALL MATTERS RELATED TO FORCE
PROTECTION AND EMERGENCY MANAGEMENT.

END QUOTE

4. ARTICLE 0802 IS AMENDED TO INCLUDE THE FOLLOWING PARAGRAPH AND READS AS
FOLLOWS:

QUOTE

0802. RESPONSIBILITY.

5. COMMANDING OFFICERS OF NAVY INSTALLATIONS, TO INCLUDE JOINT INSTALLATIONS WHERE NAVY IS THE LEAD SERVICE, HAVE THE RESPONSIBILITY TO OVERSEE AND COORDINATE MATTERS OF COMMON INTEREST TO ENSURE THE EFFECTIVE AND EFFICIENT OPERATION OF THE INSTALLATION. COMMANDING OFFICERS OF AN INSTALLATION MAY DIRECT THE ACTIONS OF ALL TENANT AND VISITING COMMANDS AND INDIVIDUALS ON MATTERS CONCERNING THE SAFEGUARDING OR PRESERVATION OF NAVY OWNED OR CONTROLLED PROPERTY, AND THE SECURITY, SAFETY AND WELFARE OF ALL INDIVIDUALS AND FAMILIES ONBOARD THE INSTALLATION. THIS AUTHORITY INCLUDES, BUT IS NOT LIMITED TO, ALL MATTERS RELATED TO FORCE PROTECTION AND EMERGENCY MANAGEMENT.

END QUOTE

5. ARTICLE 1054 IS AMENDED TO READ AS FOLLOWS:

QUOTE

1054. COMMAND ASHORE.

1. THE OFFICER DETAILED TO COMMAND A NAVAL INSTALLATION SHALL BE A NAVY OFFICER ELIGIBLE FOR COMMAND AND MAY INCLUDE STAFF CORPS OFFICERS IN ACCORDANCE WITH ARTICLE 1059. AN OFFICER FROM ANY ARMED SERVICE DESIGNATED BY SERVICE REGULATION AS ELIGIBLE FOR COMMAND MAY COMMAND A JOINT INSTALLATION WHERE NAVY IS THE SUPPORTING COMPONENT.

2. THE OFFICER DETAILED TO COMMAND A NAVY REGION SHALL BE AN OFFICER OF THE LINE ELIGIBLE FOR COMMAND AT SEA. AN OFFICER FROM ANY ARMED SERVICE DESIGNATED BY SERVICE REGULATION AS ELIGIBLE FOR COMMAND AND ASSIGNED AS A JOINT REGION DEPUTY COMMANDER, MAY TAKE COMMAND OF THE REGION IN THE ABSENCE OR DISABILITY OF THE JOINT REGION COMMANDER.

3. THE OFFICER DETAILED TO COMMAND A NAVAL SHIPYARD SHALL BE TRAINED IN THE TECHNICAL ASPECTS OF BUILDING AND REPAIR OF SHIPS AND SHALL HAVE HAD SUBSTANTIAL PREVIOUS EXPERIENCE IN THE TECHNICAL AND MANAGEMENT PHASES OF SUCH WORK. SUCH OFFICER MAY HAVE BEEN DESIGNATED FOR ENGINEERING DUTY.

END QUOTE

6. DELETE ARTICLE 1055.

7. ACTION. COMMANDERS SHALL EXERCISE THESE AUTHORITIES THROUGH NORMAL ASSIGNED CHANNELS TO THE MAXIMUM EXTENT POSSIBLE; WHEN NOT FEASIBLE, COMMANDERS SHALL PROMPTLY INFORM THEIR IMMEDIATE SUPERIOR COMMANDER. COMMANDERS AT ALL LEVELS SHALL ASSUME THESE RESPONSIBILITIES AND AUTHORITIES AND AGGRESSIVELY IDENTIFY AND SEEK RESOLUTION OF COMMAND AND CONTROL CONFLICTS WHEN ENCOUNTERED.

8. THIS CHANGE WILL BE INCORPORATED INTO THE NEXT PRINTED REVISION OF REFERENCE A.

RMKS/1. THIS CHANGE REVISES ARTICLE 1137 TO REF A. THIS CHANGE IS EFFECTIVE IMMEDIATELY.

2. ARTICLE 1137 IS AMENDED TO READ AS FOLLOWS: "1137 OBLIGATION TO REPORT CERTAIN OFFENSES, CONVICTIONS, AND ARRESTS.

1. PERSONS IN THE NAVAL SERVICE SHALL REPORT AS SOON AS POSSIBLE TO SUPERIOR AUTHORITY ALL OFFENSES UNDER THE UNIFORM CODE OF MILITARY JUSTICE WHICH COME UNDER THEIR OBSERVATION, EXCEPT WHEN SUCH PERSONS ARE THEMSELVES ALREADY CRIMINALLY INVOLVED IN SUCH OFFENSES AT THE TIME SUCH OFFENSES FIRST COME UNDER THEIR OBSERVATION.

2. PERSONS IN THE NAVAL SERVICE SHALL REPORT AS SOON AS POSSIBLE TO SUPERIOR AUTHORITY ANY CONVICTION OF SUCH SERVICE MEMBER FOR A VIOLATION OF A CRIMINAL LAW OF THE UNITED STATES OR FOREIGN JURISDICTION. A CONVICTION INCLUDES A PLEA OR FINDING OF GUILTY, A PLEA OF NOLO CONTENDERE, AND ALL OTHER ACTIONS TANTAMOUNT TO A FINDING OF GUILTY, INCLUDING ADJUDICATION WITHHELD, DEFERRED PROSECUTION, ENTRY INTO ADULT OR JUVENILE PRETRIAL INTERVENTION PROGRAMS, AND ANY SIMILIAR DISPOSITION OF CHARGES. A CRIMINAL LAW INCLUDES ANY MILITARY OR OTHER FEDERAL CRIMINAL LAW, AND ANY CRIMINAL LAW OR ORDINANCE OF ANY COUNTRY, STATE, COMMONWEALTH, TERRITORY, COUNTY, DISTRICT, PARISH, MUNICIPALITY OR LOCAL SUBDIVISION OF ANY SUCH AUTHORITY, OTHER THAN MOTOR VEHICLE VIOLATIONS THAT DO NOT REQUIRE A COURT APPEARANCE.

3. THE SECRETARY OF THE NAVY, CHIEF OF NAVAL OPERATIONS, AND COMMANDANT OF THE MARINE CORPS MAY PROMULGATE REGULATIONS OR INSTRUCTIONS THAT REQUIRE SERVICEMEMBERS TO REPORT CIVILIAN ARRESTS OR FILING OF CRIMINAL CHARGES IF THOSE REGULATIONS OR INSTRUCTIONS SERVE A REGULATORY OR ADMINISTRATIVE PURPOSE."

RMKS/1. THIS CHANGE REVISES ARTICLES 0310, 0336, 0602 AND ADDS NEW
ARTICLES 0328, 0338 AND 0339 TO REF A. THIS CHANGE IS EFFECTIVE
IMMEDIATELY.

2. ARTICLE 0310 IS AMENDED TO READ AS FOLLOWS:

THE FUNCTION OF THE OFFICE OF THE SECRETARY OF THE NAVY IS TO ASSIST
THE SECRETARY IN CARRYING OUT HIS OR HER RESPONSIBILITIES. THE OFFICE
OF THE SECRETARY OF THE NAVY IS COMPOSED OF THE FOLLOWING:

A. THE CIVILIAN EXECUTIVE ASSISTANTS:

- (1) THE UNDER SECRETARY OF THE NAVY;
- (2) THE ASSISTANT SECRETARY OF THE NAVY (FINANCIAL
MANAGEMENT AND COMPTROLLER);
- (3) THE ASSISTANT SECRETARY OF THE NAVY (MANPOWER AND
RESERVE AFFAIRS);
- (4) THE ASSISTANT SECRETARY OF THE NAVY (RESEARCH,
DEVELOPMENT AND ACQUISITION);
- (5) THE ASSISTANT SECRETARY OF THE NAVY (INSTALLATIONS
AND ENVIRONMENT);
- (6) THE GENERAL COUNSEL OF THE DEPARTMENT OF THE NAVY; AND
- (7) THE DEPUTY UNDER SECRETARY OF THE NAVY.

B. THE STAFF ASSISTANTS:

- (1) THE JUDGE ADVOCATE GENERAL OF THE NAVY;
- (2) THE NAVAL INSPECTOR GENERAL;
- (3) THE CHIEF OF NAVAL RESEARCH;
- (4) THE CHIEF OF INFORMATION;
- (5) THE CHIEF OF LEGISLATIVE AFFAIRS;
- (6) THE DIRECTOR, OFFICE OF PROGRAM AND PROCESS
ASSESSMENT;
- (7) THE AUDITOR GENERAL OF THE NAVY;
- (8) THE DEPARTMENT OF THE NAVY CHIEF INFORMATION
OFFICER;
- (9) THE DEPUTY CHIEF MANAGEMENT OFFICER/DIRECTOR OF
BUSINESS TRANSFORMATION; AND
- (10) SUCH OTHER OFFICERS AND OFFICIALS AS MAY BE
ESTABLISHED BY LAW OR AS THE SECRETARY OF THE NAVY
MAY ESTABLISH OR DESIGNATE.

3. ARTICLE 0336 IS AMENDED TO READ AS FOLLOWS: 0336. THE DIRECTOR, OFFICE OF PROGRAM AND PROCESS ASSESSMENT

(A) THE DIRECTOR, OFFICE OF PROGRAM AND PROCESS ASSESSMENT, DIRECTS, UNDER THE IMMEDIATE SUPERVISION OF THE SECRETARY OF THE NAVY, THE OFFICE OF PROGRAM AND PROCESS ASSESSMENT.

(B) THE OFFICE OF PROGRAM AND PROCESS ASSESSMENT WILL ASSIST THE SECRETARY IN ASSURING THAT EXISTING AND PROPOSED NAVY AND MARINE CORPS PROGRAMS PROVIDE THE OPTIMUM MEANS OF ACHIEVING THE OBJECTIVE OF THE DEPARTMENT OF THE NAVY.

4. PARAGRAPH 2 OF ARTICLE 0602 IS AMENDED TO READ AS FOLLOWS:

(A) WHEN THE COAST GUARD OPERATES AS A SERVICE IN THE NAVY, THE COMMANDANT PERFORMS DUTIES UNDER THE AUTHORITY, DIRECTION, AND CONTROL OF THE SECRETARY OF THE NAVY AND IS DIRECTLY RESPONSIBLE TO THE SECRETARY OF THE NAVY EXCEPT AS OTHERWISE PRESCRIBED BY LAW.

5. INSERT NEW ARTICLE 0328:

0328. DEPUTY UNDER SECRETARY OF THE NAVY.

(A) THE DEPUTY UNDER SECRETARY OF THE NAVY IS RESPONSIBLE FOR ADVISING THE SECRETARY OF THE NAVY AND THE UNDER SECRETARY OF THE NAVY ON GENERAL NATIONAL SECURITY, FOREIGN POLICY, AND INTELLIGENCE ISSUES. UNDER THE DIRECTION AND CONTROL OF THE UNDER SECRETARY OF THE NAVY, THE DEPUTY UNDER SECRETARY OF THE NAVY:

(B) ACTS AS LIAISON WITH SENIOR OFFICIALS FROM OTHER DEPARTMENTS AND AGENCIES OF THE UNITED STATES GOVERNMENT INVOLVED IN THE SAFEGUARDING OF UNITED STATES INTERESTS IN THE MARITIME ENVIRONMENT, AND CONDUCTS INTERNATIONAL OUTREACH TO FOREIGN MARITIME PARTNERS AND ALLIES;

(C) COORDINATES ALL NATIONAL SECURITY AND FOREIGN POLICY ISSUES PERTAINING TO THE DEPARTMENT OF THE NAVY WITH THE OFFICE OF THE UNDER SECRETARY OF DEFENSE FOR POLICY, INCLUDING STRATEGIC PLANNING DOCUMENTS, AND, AT THE DIRECTION OF THE SECRETARY OF THE NAVY, FORMULATES DEPARTMENT-WIDE STRATEGIC PLANS, PROGRAM OBJECTIVES, POLICIES, AND STANDARDS IN SUPPORT OF MAJOR POLICY OBJECTIVES;

(D) ASSISTS THE SECRETARY OF THE NAVY AND THE UNDER SECRETARY OF THE NAVY IN DISCHARGING THE RESPONSIBILITY FOR EFFECTIVE SUPERVISION AND CONTROL OF THE INTELLIGENCE ACTIVITIES OF THE NAVY;

(E) CONSISTENT WITH GOVERNING AUTHORITIES, PROVIDES POLICY OVERSIGHT ON ALL ACTIVITIES OF THE NAVY AND MARINE CORPS RELATING TO SPECIAL OPERATIONS FORCES AND NAVAL EXPLOSIVE ORDNANCE DISPOSAL, AND ADVISES THE SECRETARY OF THE NAVY AND THE UNDER SECRETARY OF THE NAVY ON RELATED FUNDING, MANPOWER, AND PROGRAMMATIC MATTERS; AND

(F) PREPARES DEPARTMENT-WIDE POLICY PLANNING GUIDANCE FOR THE PROGRAM OBJECTIVE MEMORANDUM DEVELOPMENT. IN COOPERATION WITH THE ASSISTANT SECRETARY OF THE NAVY (FINANCIAL MANAGEMENT AND COMPTROLLER), ENSURES THAT PROGRAMMATIC INVESTMENT ALIGNS WITH THE SECRETARY'S DEPARTMENT-WIDE PROGRAM OBJECTIVE MANAGEMENT GUIDANCE, AND ADVISES ON ALL ISSUES RELATED TO THE DEPARTMENT OF DEFENSE STRATEGIC PLANNING DOCUMENTS. ASSISTS THE SECRETARY OF THE NAVY AND THE UNDER SECRETARY OF THE NAVY WITH DISCHARGING THEIR RESPONSIBILITIES AS MEMBERS OF THE DEPARTMENT OF DEFENSE POLICY AND GOVERNANCE PROCESS.

6. INSERT NEW ARTICLE 0338:

0338. THE DEPARTMENT OF THE NAVY CHIEF INFORMATION OFFICER.

(A) THE DEPARTMENT OF THE NAVY CHIEF INFORMATION OFFICER HEADS THE OFFICE OF THE DEPARTMENT OF THE NAVY CHIEF INFORMATION OFFICE AND IS NAVY'S SENIOR INFORMATION MANAGEMENT, INFORMATION TECHNOLOGY, (INCLUDING

NATIONAL SECURITY SYSTEMS), AND INFORMATION RESOURCES MANAGEMENT OFFICIAL. SERVES AS THE SECRETARY OF THE NAVYS PRINCIPAL ADVISOR ON INFORMATION MANAGEMENT/INFORMATION TECHNOLOGY AND INFORMATION RESOURCES MANAGEMENT, AND HAS SOLE RESPONSIBILITY FOR THE INFORMATION MANAGEMENT FUNCTION WITHIN THE OFFICE OF THE SECRETARY OF THE NAVY, OFFICE OF THE CHIEF OF NAVAL OPERATIONS AND HEADQUARTERS MARINE CORPS.

7. INSERT NEW ARTICLE 0339:

0339. THE DEPARTMENT OF THE NAVY DEPUTY CHIEF MANAGEMENT OFFICER/DIRECTOR OF BUSINESS TRANSFORMATION.

(A) THE DEPARTMENT OF THE NAVY DEPUTY CHIEF MANAGEMENT OFFICER/BUSINESS TRANSFORMATION IS THE PRINCIPAL ADVISOR TO THE SECRETARY OF THE NAVY AND THE DEPARTMENT OF THE NAVY CHIEF MANAGEMENT OFFICER FOR MATTERS RELATING TO THE MANAGEMENT AND IMPROVEMENT OF DEPARTMENT OF THE NAVY BUSINESS OPERATIONS. SERVES AS THE DIRECTOR OF THE DEPARTMENT OF THE NAVY OFFICE OF BUSINESS TRANSFORMATION. OFFICER, ELIGIBLE FOR COMMAND. IF A NAVAL AIR TRAINING SQUADRON HAS BEEN DESIGNATED A MULTI-SERVICE TRAINING SQUADRON, THE OFFICER DETAILED TO COMMAND THAT SQUADRON MAY BE A LINE OFFICER FROM ANY ARMED SERVICE DESIGNATED AS THE EQUIVALENT OF A NAVAL AVIATOR OR NAVAL FLIGHT OFFICER AND OTHERWISE ELIGIBLE TO COMMAND AN AVIATION SQUADRON OR UNIT UNDER THAT OFFICER'S PERTINENT SERVICE REGULATIONS.

3. THE OFFICER DETAILED TO COMMAND A NAVAL AIR ACTIVITY OF A TECHNICAL NATURE ON SHORE MAY BE AN OFFICER OF THE LINE IN THE NAVY NOT ELIGIBLE FOR COMMAND AT SEA, BUT DESIGNATED AS A NAVAL AVIATOR OR A NAVAL FLIGHT OFFICER OR DESIGNATED FOR AERONAUTICAL ENGINEERING DUTY.

4. THE OFFICER DETAILED TO COMMAND A MARINE CORPS AVIATION SCHOOL, A MARINE CORPS AIR ACTIVITY ON SHORE OR A MARINE CORPS AIR UNIT ORGANIZED FOR FLIGHT TACTICAL PURPOSES SHALL BE AN OFFICER OF THE MARINE CORPS, DESIGNATED AS A NAVAL AVIATOR OR NAVAL FLIGHT OFFICER.

5. OTHER THAN AN AIR TRAINING SQUADRON, AN OFFICER OF THE NAVY SHALL NOT NORMALLY BE DETAILED TO COMMAND AN AVIATION UNIT OF THE MARINE CORPS NOR SHALL AN OFFICER OF THE MARINE CORPS NORMALLY BE DETAILED TO COMMAND AN AVIATION UNIT OF THE NAVY. AIRCRAFT UNITS OF PAGE 04 RUENAAA2836 UNCLAS

THE MARINE CORPS MAY, HOWEVER, BE ASSIGNED TO SHIPS OR TO NAVAL AIR ACTIVITIES IN THE SAME MANNER AS AIRCRAFT UNITS OF THE NAVY AND, CONVERSELY, AIRCRAFT UNITS OF THE NAVY MAY BE SO ASSIGNED TO MARINE CORPS AIR ACTIVITIES. A GROUP COMPOSED OF AIRCRAFT UNITS OF THE NAVY AND AIRCRAFT UNITS OF THE MARINE CORPS MAY BE COMMANDED EITHER BY AN OFFICER OF THE NAVY OR AN OFFICER OF THE MARINE CORPS.

5. NOTES REGARDING THE ABOVE CHANGES. NAVREGS 1057.1 HAS BEEN CHANGED TO BE CONSISTENT WITH THE RELEVANT STATUTE, REF C (I.E., DELETING UNITS ORGANIZED FOR "ADMINISTRATIVE" PURPOSES FROM NAVREGS 1057.1 COVERAGE). ARTICLE 1057.2 IS ENTIRELY NEW AND, CONSISTENT WITH REF C, DOES NOT REQUIRE THE COMMANDER OF A TRAINING SQUADRON TO BE A NAVAL AVIATOR OR NAVAL FLIGHT OFFICER. IT PERMITS OTHER SERVICE OFFICERS TO SERVE AS COMMANDING OFFICERS OF DESIGNATED MULTI-SERVICE NAVAL AIR TRAINING SQUADRONS. NAVREGS 1057.3 AND 1057.4

HAVE NOT BEEN CHANGED BUT HAVE BEEN RENUMBERED. NAVREGS 1057.5 ADDS THE WORDS "OTHER THAN AN AIR TRAINING SQUADRON" AT THE BEGINNING TO CONFIRM THE ACCEPTABILITY OF THE PRACTICE OF ASSIGNING MARINE CORPS OFFICERS TO COMMAND OF NAVAL AVIATION TRAINING SQUADRONS.
