## **Jillian L. Morrison**



### **Assistant General Counsel (Energy, Installations and Environment)**

Ms. Jillian L. Morrison was appointed to the Senior Executive Service and became the Assistant General Counsel (Energy, Installations and Environment) (AGC (EI&E)) on October 14, 2018. As the AGC (EI&E), Ms. Morrison is the Department's senior attorney and primary advisor to the Assistant Secretary of the Navy (Energy, Installations and Environment) (ASN (EI&E)) and the General Counsel of the Navy on environmental compliance and planning, real estate and real property management, energy, and safety law matters.

Prior to her current position, Ms. Morrison served as the Head of the Environment and Occupational Safety and Health Section within the Naval Sea Systems Command (NAVSEA) Office of Counsel. In this position, she provided environmental and occupational health and safety advice to NAVSEA headquarters elements, NAVSEA-affiliated Program Executive Officers, shipyards, and Supervisors of Shipbuilding.

Prior to joining the Department of the Navy Office of the General Counsel, Ms. Morrison served on active duty in the U.S. Navy Judge Advocate General's Corps from 1994 to 2015, retiring at the rank of Captain. Specializing in environmental law, Ms. Morrison served as the Deputy Assistant Judge Advocate General for Environmental Law, Senior Legal Counsel for the Deputy Chief of Naval Operations, Fleet Readiness and Logistics, and Senior Environmental Counsel for Commander, Navy Region Southeast. Ms. Morrison's litigation experience includes serving as the Civil Litigation Team Leader and Litigation Information Branch Head at the General Litigation Division of the Office of the Judge Advocate General; Senior Defense Counsel and Acting Executive Officer at the Naval Legal Service Office, North Central; and Trial Counsel and Physical

Evaluation Board Attorney at the Naval Legal Service Office, National Capital. Ms. Morrison has advised Navy leadership as the Command Judge Advocate to *USS L. Y. Spear* (AS 36); Staff Judge Advocate, Submarine Squadrons Six and Eight; and Staff Judge Advocate for Commander, Navy Installations Command.

Ms. Morrison graduated with highest honors from the George Washington School of Law with a Masters of Law (LL.M) in Environmental and Government Procurement Law. She earned a Juris Doctorate (cum laude) from Suffolk Law School, and a Bachelor of Arts in English from Smith College.
