

Chiefs, the following Fire Extinguishing Agent, Aqueous Film-Forming Foam (AFFF) Liquid Concentrate, for Fresh and Sea Water meeting the governing specification and approved are listed on the Qualified Product List (QPL): updated on 15-Dec 2015.

- ONLY QPL approved AFFF will be used to replace existing AFFF (old) stock piles.
- Disposition instructions to replace stockpile of OLD AFFF will be determined after data call is complete.

Regions/Installations receiving new apparatus

When placing foam into trucks please ask them to track date tanks filled, brand of foam, percent, date foam manufactured info. We will figure out automated tracking system later. Also, if funds are needed to implement immediately (do not place old foams in new trucks) send \$\$ amount needed and we will re align funds from hq.

- New apparatus will be filled with ONLY QPL approved C6 AFFF.
- TOA for new apparatus is one truck fill, plus two refill loads on-hand or in station storage or AFFF trailer.
- Do not mix old and new foams.





Note 1: The new C6 AFFF has an expiration date, so it is important to track the date foam tanks filled, brand of foam used, the percentage, and the date the foam manufactured. We will figure out automated tracking system later.

Note 2: If funds are needed to implement immediately (do not place old foams in new trucks) send a RAM for the amount require and we will re align funds from HQ.

Note 3: The current QPL list can always be viewed by anyone by going to quicksearch.dla.mil, typing "24385" into the "Document Number" box, click search, click "QPL-24385-35 NOT 1", then click" View QPD data" towards the bottom of the page.
